## A message from Our Director



We all dream of a future defined by clean energy. As greenhouse gas emissions continue to grow and as extreme weather events become more frequent and harmful, the current efforts to move beyond fossil fuels appear inadequate. A move away from oil and gas will reconfigure the world just as dramatically. Even when the world achieves net-zero emissions, it will hardly mean the end of fossil fuels.

Australia, Chile, Japan, and Saudi Arabia have emerged as early adopters in trading low-carbon hydrogen and ammonia across borders and thus may be able to set infrastructure standards and certification norms for those new fuel sources.

A clean energy world has hammered home the importance of the supply chain for minerals such as cobalt, copper, lithium, nickel, and rare earths, which are critical to various clean energy technologies, including wind turbines and electric vehicles. In the estimation of the International Energy Agency, a world on track for net-zero emissions in 2050 will by 2040 need six times as much of the critical minerals as it does today.

I am very pleased to carry out the global energy technology policy convergence manpower training program with the support of the government. 



Hanyang University is a private research university in South Korea. The main campus is in Seoul, and the second one, the Education Research Industry Cluster or ERICA campus, is located in Ansan. Hanyang derives from the former name of the capital Seoul which was used during the Chosun Dynasty. Its motto and educational philosophy is Love in Deed and Truth. The university established the nation's first engineering institute (DongA Engineering Institute) in 1939 which became the founding facility of Hanyang University. It also established the first school of architecture and civil engineering in Korea.

Hanyang University has an alumni network of 330,000 that is not limited to the field of engineering but also to other fields. In 2018, the University was ranked 1st for the number of CEO alumni of venture companies in Korea. In 2019, QS World University Rankings ranked Hanyang University 150th.

The university welcomes over 7,400 foreign students each year and more than 3,000 students study abroad annually. Hanyang University counts the Massachusetts Institute of Technology, University of Cambridge, and Tsinghua University among its 820 partner universities in 88 countries.



#### **Field Trip and Internship**



- If the students and their parents have dual citizenship, they both should lose their Korean nationality before the application date

- Candidates for the Master's Program are required to hold a Bachelor's degree.
- Candidates for the Doctoral Program are required to hold both Bachelor's and Master's degree.

It is strongly advised to prepare for required official documents in advance, as it may take weeks for an apostille or consular confirmed documents.

#### • Introduction for submitting a document to prove the academic history from overseas institutions


- All applicants except those who have graduated in China must submit an official diploma or degree and an official academic transcript verified by one of the following verification method stated below during the designated period.
- Apostilled Official diploma or degree and official academic transcript
- Official diploma or degree and official academic transcript verified by a Korean Embassy

#### • Information on Apostille Convention

- 1. Apostille Convention
- The Republic of Korea became the 90th Contracting State of the Apostille Convention (Convention Abolishing the Requirement of Legalization for Foreign Public Document), effective as of July 14, 2007
- Apostille is a certificate specifying the modalities through which a document issued in one of the signatory countries can be certified for legal purposes in all the other signatory states Apostille convention countries abolish the complex consular procedures to ensure the mutual authentication of public and official documents (Apostilled documents have the same effect as documents verified by diplomatic offices)
- 2. Apostille Convention is an international treaty drafted by the Hague Conference on Private International Law: You can check out detailed updated information regarding regional authorities at www.hcch.net
